



Riverview Charter School is committed to providing a safe teaching and learning environment for our students and staff. These plans are subject to change as the situation evolves, and best practice guidelines and recommendations are updated.

### **TRANSITIONING BETWEEN LEARNING PLANS:**

Riverview will transition between Learning Plans (All Distance to Hybrid to Low or vice versa) as a result of changes in the SCDHEC Two-week Incidence Rate index. Riverview will transition between learning plans after two consecutive weeks at the lower/higher index. SCDHEC publishes new Two-Week Incidence Rates each Monday, so if a higher/lower index is published two Mondays in a row, on the third Monday Riverview will begin the learning plan.

For example, if Riverview is engaged in All Distance Learning, due to a High index, but the index drops to Medium for two Mondays in a row, on the third Monday Riverview will begin its Hybrid Learning Plan. Parents and Teachers will be notified during this two-week period of the potential change, with final notice being sent out via email on the Tuesday prior to starting the new learning plan on the following Monday.

### **MEDIUM INDEX = HYBRID PLAN**

(As defined by SCDHEC as the "Two-week Incidence Rate: the number of new cases in the prior two weeks per 100,000 people. "A Medium index is a Two-week Incidence Rate between 51 and 200 across Beaufort County)

#### **ON-SITE LEARNING: 4 days/week for students who choose to participate on-site**

  - Extended Access K-5 students will continue on-site after 11:30am with Lunch, Recess and Specials. (Exact times vary for these activities based on individual grade levels)

- Grades 6 - 8, Monday through Thursday
  - 8:00am - 8:30am Extended Access Arrival for MS Students
  - 8:30am to 8:45am Homeroom

  - 9:50am to 10:45am Special II on M/W & Special IV\*\* on T/Th
  - 10:50am to 11:50am Recess and Lunch

Individual schedules will be provided so students know when their specific Core Content and Specials will meet, including their Study Hall period

**Additionally, during implementation of a HYBRID SCHEDULE:**

Families may apply for students to have "Extended Access" from 8:30am - 3pm, Monday through Thursday. Space for this service will be limited, and priority will be given to the following groups of students in this order:

- Children of Riverview Faculty & Staff Members
- Students with IEPs, 504s or those who qualify for ESOL instruction that can best be implemented in person
- Students with parents who work full-time as essential workers
- Students of single, full-time working parents who qualify for subsidized meals
- Every effort will be made to keep siblings together, but cannot be guaranteed due to space constraints.
- All other requests on a case by case basis

**Note, during implementation of a HYBRID SCHEDULE:**

- Riverview will provide breakfast and lunch to on-site students who qualify for free or reduced-price meals. There will be designated times and places for students to receive meals during each transition time (8am to 8:30am, 11am to 12noon, and 3:00pm to 3:30pm daily.)
- Students who are full pay and remaining on campus through Extended Access should bring lunch from home.
- Students dismissing or arriving mid-day, should eat before and/or after school.
- Students who choose to maintain 5 days of Distance Learning during implementation of our Hybrid Schedule will be able to pick-up meals at the same days and times noted under ALL DISTANCE LEARNING. This includes daily meals as well as 3 Day Bundles.
- Bus Transportation is currently not available. If this would change, all families will be notified via email, and the same application will apply as outlined under ON-SITE LEARNING FOR ALL STUDENTS.
- Tidewatch will not be available.
- Masks are required of all students and staff while on campus, except for those who qualify for a medical exemption (we will publish information and an application for this on our website)



- Social Distancing will be practiced to the extent possible but Riverview cannot guarantee that students and staff members will not come within 6' of another student or staff member while on campus.
- Students and staff members may have to isolate or quarantine due to exposure to Covid-19 while on campus (or in the community). Riverview will publish (on its website) detailed information from SCDHEC about isolation and quarantine guidelines for students and staff members so they know what to expect in case of exposure.
- If students must isolate or quarantine, they may participate in distance learning to the extent that they are physically able.
- Riverview reserves the right to discontinue on-site learning if it cannot safely staff the building due to a significant number of staff members in isolation or quarantine. If this should occur, the school will notify parents via email and will continue with distance learning until on-site learning can resume.
