

Enrollment Lottery Procedures for 2021 - 2022

1. If during the Open Enrollment period (January 1-31, 2021) more applications are received than space is available per grade level, families will be notified in writing that the student's acceptance at Riverview will be subject to a State mandated lottery due to an oversubscription in the grade level that their child is applying for. The lottery meeting is public and therefore all families of affected students are encouraged, but not required, to attend.
2. Members of both the Riverview Charter School Board of Directors and the Beaufort County Board of Education will be on hand to ensure lawful operation of the lottery, per page 8 of 226 of the charter contract. Additionally, a "Sponsor representative" from Beaufort County School District will "draw" the applicant's number at the public meeting.
3. A random lottery number will be assigned to each applicant. Grade level "strands" for all assigned lottery numbers will be prepared in an Microsoft Excel file based on the following weighting system, in keeping with the terms of the Agreement to Amend the Beaufort County Public School Title VI Desegregation Plan Re: Riverview Charter School, as revised May 10, 2010.

Kindergarten:

- **1 lottery number entry for each applicant;**
- **4 additional lottery number entries if the child resides in zip codes: 29945;**
- **4 additional lottery number entries if the child resides in a Single Parent home**
- **3 additional lottery number entries if the child resides in zip codes: 29920, 29940, 29906;**
- **3 additional lottery number entries if the child currently attends one of the following preschool programs: Beaufort-Jasper EOC Head Start, JJ Davis Elementary, St. Helena Elementary School, First Baptist Church, Lady's Island Elementary, Beaufort Christian School, Pritchardville Elementary School, Mighty Kids Preschool;**

1st Grade:

- **1 lottery number entry for each applicant;**
- **3 additional lottery number entries if the child resides in zip codes 29945, 29941, or 29920;**

2nd Grade:

- **1 lottery number entry for each applicant;**
- **3 additional lottery number entries if the child resides in zip codes 29906 or 29940;**

3rd Grade:

- **1 lottery number entry for each applicant;**

- **3 additional lottery number entries if the child resides in zip codes 29920 or 29903;**

4th Grade:

- **1 lottery number entry for each applicant;**
- **3 additional lottery number entries if the child resides in zip codes 29920, 29940, 29945 or 29935;**

5th Grade:

- **1 lottery number entry for each applicant;**

6th Grade:

- **1 lottery number entry for each applicant;**

7th & 8th Grade:

- **No lottery drawing as no seats are available for these grade levels;**

The lottery drawing for all grade levels will be held **Thursday, May 27, 2021 at 5:00pm on Zoom.**

4. At the public meeting, the procedures for the lottery will be publicly reviewed prior to the drawing of any lottery cards.

5. For each grade level lottery, a “grade level strand file” will be uploaded to www.Random.org’s “Third Party Draw Service”. The Sponsor representative will then initiate the drawing of lottery numbers through the online service and a file of outcomes will be immediately projected on the wall/screen.

6. Upon conclusion of each grade level drawing, the outcomes will be reviewed and all siblings of newly enrolled students will be added to the appropriate wait list(s) that will be visibly displayed during the meeting.

7. This process will continue until all of the online drawings have been concluded. The class roster for the affected grade level will include the students whose names were drawn in lottery order equaling the number of enrollment openings for that grade. The remaining names will compose the wait list for that grade by order of their lottery number.

8. In compliance with the SC Charter Schools Act (Section 59-40-50 (8)), Riverview’s policy is to give enrollment priority to a sibling of a pupil currently enrolled and attending; to children of charter school employees; and to children of the charter committee if priority enrollment for children of employees and of the charter committee does not constitute more than twenty percent (20%) of the enrollment of the charter. Riverview Charter School will honor these special circumstances for priority status enrollment and applicants with “priority” status will be exempt from lotteries. Additionally, applicants living within Beaufort County will be given priority status

over applicants residing outside of Beaufort County, per (SCCSA 1996, Section 59-40-145) but in-district applicants will not be exempt from lotteries unless they meet the above mentioned criteria.

9. Lottery results will be posted on the school's website at www.RiverviewCharterSchool.org within forty-eight (48) hours of conclusion of the lottery.

10. An Enrollment Agreement link shall be emailed to each accepted student within three business days of the lottery. The digital materials will state: ***All information included in the Enrollment Agreement must be digitally submitted to Riverview Charter School no later than noon on Monday, June 14, 2021, for a student to be "enrolled". Failure to complete and submit the Enrollment Agreement within this timeframe will be considered declining enrollment at Riverview, and the student's space will be given to the next student on the wait-list.***

11. The Wait List will be posted to the Riverview Charter School website within 3 business days. If an enrollment space comes available, the next student on the wait-list will be notified by telephone to accept or decline the space. *(Please ensure that Riverview has a current phone number for your family!)* If the enrollment space is accepted, an Enrollment Agreement link will be emailed to that family immediately.

12. Acceptance to Riverview through lottery may not be deferred to another school year. Families who decline enrollment may not keep their seat but may be moved to the end of the current waitlist if they would like to be considered for future openings.

13. If a family has multiple students on the waitlist and one child is offered an enrollment seat, once that offer is accepted the remaining siblings on the waitlist will be treated as siblings of an enrolled student and given priority enrollment status. This does not guarantee an immediate enrollment for those siblings as we can only enroll students on a space available basis.

14. There is no appeal process when an applicant is denied admission because of lottery results. (SCCSA 1996, Section 59-40-50 (7))

15. Applications are only valid for the current year and applicants must reapply annually if we are unable to offer them admission for the current school year due to oversubscription.

Definitions:

Charter Committee Members: The 'charter committee', as defined by the SC Charter Schools Act (1996), means "the governing body of a charter school formed by the applicant to govern through the application process and until the election of a board of directors is held." Riverview's charter committee members are parents, educators or community members who serve on one or more of the seven (7) governing committees. Charter committee members are identified by name and committee in the

charter contract as was approved by the State Charter Advisory Committee on August 5, 2008, and approved by the Beaufort County Board of Education on July 18, 2009.

Sibling: Siblings are defined as any two (2) or more students who share a legal parent/guardian or share the same primary residence.

"In-District": Students whose primary residence is within Beaufort County or military families who hold orders to report to Beaufort on or before the first day of school (August 11, 2021).

"Out of District": Students whose primary residence is not within Beaufort County.
