Financial Report: Lamarr Cooler, Treasurer

As of May 31, 2021 Balance Sheet cash was \$2,497,061. Total Current Liabilities as of May 31 was \$274,272.

Total Revenue for May was \$710,762 vs. budgeted Total Revenue of \$693,055. Year to date Total Revenue was \$7,255,286 vs. budgeted Total Revenue of \$7,630,483.

Total Operating Expense for May was \$610,431 vs budgeted Total Operating Expense of \$612,187. Year to date Total Operating Expense was \$6,871,406 vs. budgeted Total Operating Expense of \$7,443,688.

Year to date Reserve Account Expense totals \$41,055 vs. Budget of \$70,583.

Net Income for the 11 months ended May 31, 2021 was \$342,825 vs. Budgeted Net Income of \$116,212.
